

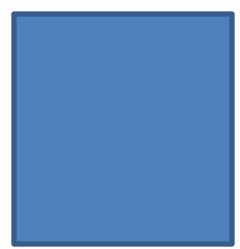

STOCKIEST POLICY

1. Pre-requisite

- (i). Must be an active distributor.
- (ii). Must have valid Sales Tax Registration Number
- (iii). Must have signed and submitted stockiest application form along with Rs.15000/= toward stockiest registration fee to H.O.
- (iv). should play a major role in organizing meeting, training and workshop (Subject to prior approval of the company).
- (v). Should not be currently involve in any similar business , which pose a competition to Zenith Multi Services Pvt.Ltd. E.g. Any MLM/ Health Care Products etc..
- (vi). Should be financially sound to invest at any point of time Rs.200,000/=
- (vii) Should have all communication devices including computer and Internet.
- (viii) Should have a minimum space of 600sq. feet for warehouse and office.
- (ix) Should be an ethical business man and abide all the rules and regulation of **Zenith**.

2. Stockiest Policy

INITIAL PURCHASE

It is mandatory for the AREA STOCKIEST to have initial purchase of products and starter kits for Rs.2,00,000 in which minimum 50% should hold Starter Kit and minimum 50% should hold products.

MINIMUM STOCK LEVEL:

Stockiest must maintain "Minimum Stock Level " of Rs.2,00,000 worth of products at any point of time .

MINIMUM SALE:

Stockiest is required to have a minimum monthly sale of Rs.2,00,000 required monthly sale for three (3) months , the company shall review the stockiestship and the

COMPANY. has the right to declare or recommend the opening 01' the area to another Stockiest. However the first month from the date of stockiest registration will be a cooling period where Minimum sale clause will not be applicable.

MINIMUM ORDER:

Minimum Order at any point of time is Rs.50, 000\= . Freight charges for the order above Rs.50, 000 will be borne by the Company.

SALES TAX:

Sales tax for the sale made by the Stockiest will be reimbursed by the Company on the submission of proof of payment. All the reimbursement will be made in the form of kits & products only. Stocks will be transferred against "C Form "only from the Company to the Area Stockiest if there is no State Stockiest is appointed. If the Area Stockiest could not provide "C-Form", the Company will not bear the local sales tax of such Area Stockiest.

AREA STOCKIST COMMISSION:

Stockiest is eligible to get commission on their monthly performance as follows:

a. Stockiest will get incentive for products repurchase

Rs. Kit Sale 2 % (ADVANTAGE PACK)

Rs. Kit Sale 2 % (REGULAR PACK.)

b. Stockiest will get incentive for Cell Booster/Toxic leaner repurchase

Rs. 2 % On Cell Booster 1 Peace

Rs.2 % On Toxic leaner 1 Peace

COMPANY STATIONARY:

Company provides bill book to the stockiest. Other materials such as flyers books can be ordered to the Company at extra cost.

STOCKIST SUBMISSION:

Stockiest should submit their weekly sales through online regularly.

BOM MEETING:

Stockiest should conduct regular monthly BOM meetings within their assigned territory for which Company may support on the meeting expenses on submission of bills to a certain extent which will be at the sole discretion of the Company. Reimbursement from the company will be made in the form of products only.
